

申請方法

只需 3 個步驟：

1. 開立致富港股戶口。
2. 填妥「月供股票計劃」服務申請表。
- 3a. 如以股票戶口之結餘供款，客戶需存入首月供款金額；
- 3b. 如以銀行自動轉帳方式供款，客戶需填妥「直接付款授權書」，存入首兩月供款金額及繳付一次性之首次登記費 (港幣\$50)，日後取消自動轉帳服務，有關費用亦不作退回。

更改服務

1. 填妥及簽署「月供股票計劃」服務申請表
2. 如以銀行自動轉帳方式供款，新的供款總額高於舊有授權書的最高付款限額，則需要重新填妥一份「直接付款授權書」。

中止服務

1. 填妥及簽署「月供股票計劃」服務申請表 及
2. 如以銀行自動轉帳方式供款，需填妥「直接付款授權書取消表格」*
